The project will work with the Space Bus and use the new all-weather pitch. The project aims to engage between 50 and 100 young people each week.		

Comments:	This project focuses on engaging with young people from some of the more deprived wards in the Burnley area and will contribute to reductions in ASB and arson.

Summary:	The project provides a range of sport activities on a Friday evening for young people identified by the Police as at risk of being involved in ASB or criminal damage.		
Comments:	The Gym has secured funding from Sportivate and are looking for further funding to extend the programme from 32 sessions to 50 sessions and to increase the number of young people able to attend.

Summary:	The project provides security checks and items for victims of domestic abuse to enable them to remain within their own homes. Rossendale does not have any refuge provision so this service is vital to ensuring that victims can safely remain in the area if they wish.  This can positively contribute to their ability to recover and enables families to be kept together reducing the impact of domestic abuse on children.		
Comments:	As there is a lack of refuge provision in the area this service is an essential addition to the services and facilities that the Star Centre already provides.

The project uses a mentoring approach to working with offenders.  The project is located in the centre of Preston at various venues and involves young and adult offenders from across Lancashire.		

Comments:	This project is fully supported and part funded by Probation/CRC and is seen by them as an effective tool to reduce re-offending. The use of mentors is in line with the Commissioner's approach to supporting projects that use peer support models alongside input from professionals.
