Project Name & Cost	Nayee Soch – A New Way of Thinking £5,362		
Summary:	The Maa Aur Baccha Group works with mothers and daughters from the BME community. The group discusses relevant issues such as westernised society, peer pressure, social media etc. The group works with 120 women and girls but wishes to run a pilot project which allows 20 members to take part in weekend of activities with the aim to discuss cultural issues.		
Comments:	Two Lancashire Constabulary colleagues (1 Police Officer & 1 Police Staff) who work closely with the group will run the following sessions over the weekend: <ul style="list-style-type: none"> • Honour Based Violence; Forced Marriage; CSE and Domestic Violence • The Police family – what roles are available in the Police for BME girls. This workshop aims to break down barriers / fears about the Police.

Comments:	Nelson FC in the Community developed this initiative following consultation with local residents and partners. The football inclusion project will target the Bradley ward, an area identified by local people.

The grounds have recently been subject to recent drug related activity and therefore would like to secure their premises further. The Cricket Club are working with the local police, neighbourhood watch scheme and local councillor to help tackle the issue.

Details:	The Reachout.work project aims to work with vulnerable foster families and children, in particular those who struggle with mainstream schools due to mental health issues, emotional needs or learning disabilities. The project aims to help young people access educational support on a 1:1 basis or a small group setting.
