PART II

1. Background and Advice

- 1.1 The Police Pension Regulations 2006 (SI 2006/3415, as amended) provide for the forfeiture of police pensions in cases where either a particular offence has been committed or an offence has been committed in connection with service which is certified by the Home Secretary to be particularly serious. The Police and Crime Commissioner's (the Commissioner) Procedure for Forfeiture of Police Pensions has been reviewed and revised to ensure that is sufficiently robust for any such situation.
- 1.2 The Commissioner may apply for forfeiture of a police pension in cases where an officer, or their adult survivor who is in receipt of a police pension payable after the death of the officer to whom the pension was granted, is convicted of specified offences namely: "(a) an offence of treason, (b) one or more offences under the Official Secrets Acts 1911 to 1989 for which the grantee (of the pension) has been sentenced on the same occasion to a term of imprisonment of, or to two or more consecutive terms amounting in the aggregate to, at least 10 years" or in the case of a pensioner "who has been convicted of an offence committed in connection with his (or her) service as a member of a police force which is certified by the Home Secretary either to have been gravely injurious to the interests of the State or to be liable to lead to serious loss of confidence in the public service."
- 1.3 The procedure attached as Appendix 'A' outlines the formal procedure associated with the Commissioner's application to the Home Secretary for a certificate of forfeiture. It gives details of the responsibilities of all parties to the process, and information regarding right of appeal.
- 1.4. This procedure has been drafted to ensure that it is in-line with the Police Pension Regulations and to comply with the principles of the Human Rights and Equal Opportunity legislation as outlined in the "Equality and Human Rights Commission Guidance".

The procedure will contribute to ensuring public confidence in the police, and thus will contribute to the effective delivery of the Police & Crime Plan.
