## **Executive Summary**

The Commissioner has established a Community Action Fund and has allocated £100,000 to the Community Action Fund for 2018-19

Applications are invited from voluntary, community and faith (VCF) sector constituted organisations. The Fund is administered by LANPAC on behalf of the Commissioner.

LANPAC has received 8 applications in December 2018 which have been reviewed in line with the terms and conditions and criteria of the Fund as follows:
