<p>Executive Summary The Commissioner has established a Community Action Fund.</p> <p>In 2014-15 the fund available was £50,000 with approved applications totalling £50,684, the additional funding being an under-spend from 2013-14.</p> <p>As a result of increasing interest from community groups and organisations the Commissioner has increased the Community Action Fund in 2015-16 to £75,000 to maximise the impact of the Fund whilst ensuring that it is at a level that can be fully allocated.</p> <p>Applications are invited from voluntary, community and faith (VCF) sector constituted organisations. The Fund is administered by LANPAC on behalf of the Commissioner.</p> <p>LANPAC has received 9 applications in November/ December 2015 which have been reviewed in line with the terms and conditions and criteria of the Fund as follows:</p> <table><tr><td>1.
