# **Executive Summary:**

Military School intervention working in partnership with Burnley Council – supporting children and parents from Stoops Estate – one of the most deprived areas in the town. Costs would be £5,900 – 11, 200k

Aim – Run a pilot Summer School capturing up to 100 children and offer free support and places to parents.

Core objectives – reduce ASB, improve resilience and educational attainment in addition to wider knowledge in respect of Health and Wellbeing and improve outcomes for young people.

# 'Appendix B

Following initial dialogue with Director of OPCC and Pam Smith from Burnley Council regarding a pilot project in Burnley for a holiday school.

Burnley Council have linked in with Wayne Forsyth from Military School who has achieved great success in working with some of the deprived areas in Liverpool and produced feedback from these sessions to demonstrate the success in reducing anti-social behaviour in the 6 week school holidays throughout the summer and a noticeable attitude of the children on their return to school.

The military school had previously working with councils and housing trusts in a partnership approach to the engagement.

In dialogue with Wayne from Military School he has evidenced the following in respect of the points that are focussed on in respect of the courses

- Values
- Extremism/Radicalisation
- Team Building
- Confidence and Self Esteem Building
- Development on functional maths and English
- Bushcraft, Survival and Forrest School
- Staff Development/Leadership.

The mission for the Military School is to influence those attending and have a positive impact on the following areas:

Being a strong role model to parents and children Reducing ASB in the more challenging clusters of communities Providing a memorable experience to families and children Creating a better community cohesion

Providing a safe, energetic and challenging experience to the children who attend the camp Crating a happier and healthier relationship between the family household.

## Costings:

£18.50 per day per child and/or £28 if the child is taken off site.

The intention would be to target and reach between 50 - 100 children but ideally 80 resulting in a costing of between £5,940 - £11,200.

The venture is recommended as a one off cost to consider working further in partnership with Burnley Council to consider future supportive schemes through the Community Safety Partnership.
