2. Under paragraph 4.5.4 of the Scheme of Delegation the Director has authorised the financial settlements in relation to three employment matters.
3. Under paragraph 4.3.1 of the Scheme of Delegation, the Director has entered into a Service Level Agreement with Chief Constable relating to the position and appointment of the Data Protection Officer required in accordance with the General Data Protection Regulation 2016.

4. Under paragraph 4.5.2 of the scheme of delegation the Director has approved to restructure the OPCC to create the post of a DPCC, extend the post of Deputy Director to November 2018 and to remove the post of Senior Public Affairs Officer.
5. Between the 1 March 2018 and 12 June 2018, under paragraph 4.6.2 of the Scheme of Delegation and in accordance with the Director's authority, the Governance and Policing Lead has considered 2 complaints (9 allegations) against the Chief Constable.
6. Under paragraph 4.3.2 of the scheme of delegation the Director has approved a number of warranties in relation to the new Blackpool Police Station.
7. Under paragraph 4.3.2 of the scheme of delegation the Director has signed a Covenant Deed in relation to the land to the East of Saunders Lane, Longton.
