**Executive Summary** 

This report sets out the proposed allocation of £801,536.84 per annum for three years of Ministry of Justice (MoJ) funding. This has been awarded to the Police and Crime Commissioner for Lancashire to provide support for victims of domestic abuse and sexual violence.

This report also records the decision of the MoJ to allocate the PCC funding of £185,735 in 2022/23 and then £256,799 in both 2023/24 and 2024/25 for five additional IDVAs (Independent Domestic Violence Advocate), to be placed in organisations identified by the MoJ through a needs assessment process.

## Recommendation

The Police and Crime Commissioner is asked to:

- 1. Approve the allocation of three-year funding to the organisations listed in appendix A for the provision of support to victims of domestic abuse and sexual violence
- 2. Note the organisations who submitted unsuccessful bids for this funding, listed in Appendix A
- 3. Note the MoJ's decision to award IDVA funding to five organisations for a period of three years

# 1. Background and Advice

The OPCC issued a call for proposals to populate a needs assessment in May 2022, detailing demand for domestic abuse and sexual violence provision across all services in Lancashire.

In issuing the call, the OPCC identified the following priority areas for funding, to best add value to the commissions already in place:

- Children
- Support for older victims
- By-and-for provision for BAME and LGBTQ communities
- Refugee and Asylum seeker support
- Health IDVAs
- Stalking and harassment

The Ministry of Justice (MoJ) awarded Lancashire £801,536.84 per annum for a period of three years to allocate to services.

All bids were assessed giving consideration to the additional value they added to the "basic" commissions across the three local authority footprints, geographic spread and value for money.

Appendix A details the successful applications and proposed awards, and the unsuccessful organisations.
