Executive Summary

This report sets out a revised Reserves Strategy for 2024/25 for the PCC's approval.

The revision reflects guidance from the Home Office and the forecast year-end position on reserves.

This strategy forms an integral part of the Commissioner's Medium Term Financial Planning process that enables the effective planning and control of the revenue budget and the capital investment programme.

Recommendation

The Police and Crime Commissioner is recommended to approve the Reserves Strategy for 2024/25.

1. Background

- 1.1. Forming part of the overall financial management strategy for the Police and Crime Commissioner, the Reserves strategy sets out the Commissioner's plan for the management of his reserves and the contribution they make to funding the policing service in Lancashire in 2024/25.
- 1.2. The strategy is reviewed annually and is shown at Appendix A.
