Project Summary:

The Youth & Community Van provides mobile outreach and educational support to young people across Burnley. It operates during the day in schools and community settings and in the evenings within local neighbourhoods, offering a safe space, guidance, and positive engagement opportunities. The van was recently vandalised, prompting a funding request to restore and enhance its facilities.

Summary of Activities:

- **Sports & Team-Building Activities:** Delivered in parks and recreational areas to promote positive engagement.
- **Educational Workshops:** Covering ASB, drug and alcohol awareness (including ketamine), sexual health, bullying, internet safety, family dynamics, school challenges, and career aspirations.
- **Community Clean-Ups:** Involving young people in litter picking, graffiti removal, and civic pride initiatives.
- **Mentorship & Guidance:** Building trust and signposting to specialist services.
- **Informal Sessions with Partners:** Delivered by teams such as EmPower, EAST Sexual Health, and Police.

Issue Identified:

- ASB including vandalism, unsafe use of vehicles, graffiti, and intimidation
- Reduced feelings of safety among residents
- Increased pressure on police resources

- Teen issues such as mental health, substance misuse, bullying, and exploitation

No. Of Individuals Expected to Engage:

Not explicitly stated, but expected to be significant through outreach and school/community sessions.

The concept is engaging and clearly having a positive impact within the community. Participant Works is recognised as a respected delivery partner in the area, which adds credibility to the proposal. However, there are a few points that require clarification:

- **Repair and Upgrade Costs:** The funding request appears to focus on damage repairs and upgrades. It would be helpful to understand whether these costs were anticipated and budgeted for when the van was originally purchased.
- **Previous Funding:** It's noted that upgrades such as the PlayStation may have been funded previously, possibly under the former Commissioner. We would like to know what preventative measures are now being put in place to protect the van from further damage.
- **Insurance Coverage:** As raised by colleagues, it's important to confirm whether any of the repair costs are covered by a valid insurance policy.

ASB, Prevention and Problem-Solving
Command

This application focuses on using a youth van to engage with young people around the Burnley area. Run by Participation Works, who are a valued partner in East Lancashire. Participation Works have spent many years engaging with young people around the Burnley area and I have personal experience of their work from when I was CBM in Padiham. At that time, they had the Space Bus which sounds similar to this project. This was well kitted out and as such, attracted huge numbers of young people. One thing I know, is that the van needs to be kitted out with the latest tech / gadgets to attract young people. With this, it needs to be secure. This bid is for new kit but also for additional security features, which will hopefully prevent any further thefts. Furthermore, this van replaces the traditional static youth centre. Because it is mobile, it has the opportunity to be accessible to a much larger number of children, which can only be seen as a positive. I would be more than happy to support this, especially as it is being run by Participation Works.
