Executive Summary <p>The Commissioner has provided funding for the provision of grants to enable activity that supports the delivery of his Police and Crime Plan.</p> <p>The Member of Parliament Fund provides grants of up to £50,000 to deliver activity that will address one or more of the Police and Crime Plan priorities:</p> <ul style="list-style-type: none">• Prevent Violence Against Women and Girls• Tackle Crime and Anti-Social Behaviour• Get Tough on Serious Violent Crime• Rebuild Trust and Confidence in Policing <p>This activity must also address one or more of the local area's strategic priorities.</p> <p>The Police and Crime Commissioner received an application from Burnley's MP.</p>	
Recommendation <p>The Police and Crime Commissioner is asked to approve the allocation of £4,500 to Burnley MP's sponsored project with Participation Works North West to deliver the Youth and Community Van project.</p>	

PART I

1. Background and Advice

The PCC recently launched a dedicated funding round to allow each of Lancashire's 16 MPs the opportunity to apply for funding to support community safety initiatives within their constituencies. They can propose schemes for consideration by the Commissioner through the application process, with a total funding cap of £50,000 per MP.

Oliver Ryan, MP for Burnley has submitted an application in support of the *Youth and Community Van project* led by Participation Works North West. The provides mobile outreach and educational support to young people across Burnley. It operates during the day in schools and community settings and in the evenings within local neighbourhoods, offering a safe space, guidance, and positive engagement opportunities.

The application requests **£4,500** as a grant contribution to restore and enhance the facilities of the existing van. The total project cost is **£4,500**. The project demonstrates strong sustainability planning and has already shown measurable impact in reducing anti-social behaviour and increasing youth engagement.
