<b>Executive Summary</b> <p>The Commissioner has provided funding for the provision of grants to enable activity that supports the delivery of his Police and Crime Plan.</p> <p>The Member of Parliament Fund provides grants of up to £50,000 to deliver activity that will address one or more of the Police and Crime Plan priorities:</p> <ul style="list-style-type: none"><li>• Prevent Violence Against Women and Girls</li><li>• Tackle Crime and Anti-Social Behaviour</li><li>• Get Tough on Serious Violent Crime</li><li>• Rebuild Trust and Confidence in Policing</li></ul> <p>This activity must also address one or more of the local area's strategic priorities.</p> <p>The Police and Crime Commissioner received an application from Preston's MP.</p>	
<b>Recommendation</b> <p>The Police and Crime Commissioner is asked to approve the allocation of £40,863 to Preston MP's sponsored project with The Foxton Centre to deliver the Foxton Specialist Women's Centre Project. This funding will be distributed over a two-year period.</p>	

## **PART I**

### **1. Background and Advice**

The PCC recently launched a dedicated funding round to allow each of Lancashire's 16 MPs the opportunity to apply for funding to support community safety initiatives within their constituencies. They can propose schemes for consideration by the Commissioner through the application process, with a total funding cap of £50,000 per MP.

**Mark Hendrick MP for Preston** has submitted an application in support of the **Foxton Specialist Women's Centre** project, led by **The Foxton Centre**. The project provides a trauma-informed, wraparound support service for women involved in sex work, survival sex, or at risk of exploitation and violence.

The project aims to expand the current women's outreach service from two to four nights per week, with additional daytime follow-up sessions. It will be led by four sessional staff trained by experienced professionals, including qualified IDVAs and counsellors.

The application requests a total grant contribution of **£40,863** to expand the current women's outreach service from two to four nights per week, with additional daytime follow-up sessions. The total project cost of **£40,863** will be split evenly over two years, with a **50%** contribution of **£20,431.50** provided each year.
