Project Brief:	<p>Project Name: Foxton Detached Youth Work Project Duration: Ongoing (12 Months) Funding Requested: £5,000</p> <p>Project Aim: To engage young people in Preston who are not in education, employment, or training (NEET), including those missing from education, recently relocated, or at risk of exploitation, in order to reduce daytime anti-social behaviour and improve long-term outcomes.</p> <p>Key Interventions:</p> <ul style="list-style-type: none">• Detached youth work twice weekly in hotspot areas• Partnership working with police, education, and social services• Support and referrals to local services (e.g. MASH, Children & Family Wellbeing)• Use of local hubs (e.g. Foxton Centre, bus station unit) for safe engagement• Multi-agency response coordination for at-risk youth

ASB Breakdown by Type

Boundary 1:

- Youth-related: 32 (20%)
- Moto nuisance: 12 (7%)
- Alcohol-related: 11 (7%)

Boundary 2:

- Youth-related: 8 (29%)
- Moto nuisance: 5 (18%)
- Alcohol-related: 1 (4%)

City-Wide ASB Trends (Apr–Sep 2025)

- Total ASB reports: 3,731 (↑6% from same period in 2024)
- Youth-related ASB: 19% of total
- Peak ward for ASB: City Centre (949 incidents)
- Highest youth ASB volume: City Centre (179 incidents)
- Highest youth ASB proportion: Fishwick & Frenchwood, Cadley wards
- Moto nuisance peak: Ribbleton ward (62 incidents)
- Alcohol-related ASB peak: City Centre ward (90 incidents)

Education Data Summary – Preston

- **Electively Home Educated (EHE):** 350 children
- **Children Missing Education (CME):** 297 children (27% of Lancashire total)
- **Not in Education, Employment, or Training (NEET):** 218 young people (5.4%)

- Overall attendance: 94.6%
- Persistent absentees: 1,606 pupils
- Severely absent pupils: 121
- FSM pupils: Attendance 91.78% | PA: 835 | SA: 66

Secondary Schools

- Overall attendance: 94.1%
- Persistent absentees: 1,130 pupils
- Severely absent pupils: 162
- FSM pupils: Attendance 90.09% | PA: 638 | SA: 111

Pupil Referral Units (PRU)

- Overall attendance: 38.47%
- Persistent absentees: 186 pupils
- Severely absent pupils: 128
- FSM pupils: Attendance 37.76% | PA: 133 | SA: 92

This data highlights significant challenges in school attendance and engagement, particularly among FSM pupils and those in PRUs. It underscores the need for targeted interventions to support vulnerable groups.
