<b>Executive Summary</b> The OPCC, in partnership with Lancashire Constabulary and LANPAC, is proposing a targeted initiative to reduce retail crime and anti-social behaviour (ASB) across Lancashire. This project will focus on high-risk retail environments and public spaces where ASB is prevalent. It aligns with the Police and Crime Plan priorities, supports Operation Vulture, and complements the Government's Winter of Action campaign.	
The proposal includes: <ul style="list-style-type: none"><li>Deployment of 15 Safer Pods to provide visible deterrence and reassurance.</li><li>Enhanced partnership working between police, local businesses, and community safety partners.</li><li>Innovative approaches to improve public confidence and reduce crime.</li></ul>	
<b>Recommendation</b> The Police and Crime Commissioner is asked to approve the allocation of <b>£17,920</b> from the Business and Retail Crime fund to implement this initiative.	

## **PART I**

### **1. Background and Advice**

Retail crime and anti-social behaviour (ASB) remain persistent challenges across Lancashire, impacting businesses and undermining community confidence. Under Operation Vulture, Lancashire Constabulary has identified retail hotspots that require targeted intervention.

To address this, the Commissioner has allocated £50,000 through the Business and Retail Crime funding offer, aimed at supporting innovative solutions that reduce crime and enhance public reassurance.

This proposal utilises that funding to deploy 15 Safer Pod Units in high-risk retail areas and open spaces associated with ASB and the night-time economy. These units provide:

- Visible deterrence to discourage offending behaviour
- Intelligent monitoring for real-time oversight
- 24/7 surveillance with rapid deployment capability
- No requirement for onsite power, ensuring flexibility

This approach complements existing policing activity and aligns with OPCC priorities for crime prevention and safer communities.

£17,920 exc. VAT (£22,504 inc. VAT) to be allocated from the POCA Reserves.
