Executive Summary <p>This recommendation seeks the approval of the Police and Crime Commissioner to allocate £430,820.00 to the Lancashire County Council commissioned Domestic Abuse service through the Ministry of Justice DA/SV allocation for 2 years.</p>	
Recommendation <p>The Police and Crime Commissioner is recommended to allocate £430,820.00 to Lancashire County Council to uplift the DASSL contract via a Memorandum of Understanding (MoU) for two years.</p>	

PART I

1. Background and Advice

- 1.1 On December 1st, 2025, the Office of the Police and Crime Commissioner received notification from the Ministry of Justice of Lancashire's grant allocation for 2026/27 – 2027/28. Lancashire OPCC have been allocated £2,410,747.03 in 2026/27 and £2,458,961.97 through the additional DA/SV funding.
- 1.2 This recommendation paper seeks the approval of the Police and Crime Commissioner to allocate a portion of the funding through the Ministry of Justice additional DA/SV grant to uplift the Domestic Abuse Support Services Lancashire (DASSL) contract commissioned by Lancashire County Council.
- 1.3 DASSL is a partnership made up of SafeNet (lead provider), Loving Me, PAC Be Free, Key Unlocking Futures, HARV, FCWA and the Liberty Centre.
- 1.4 The Lancashire County Council DASSL service provides support to victim-survivors of domestic abuse via community-based support and safe accommodation. The OPCC have awarded the domestic abuse contract to the DASSL partnership with service delivery starting April 1st, 2026. Appendix A: Decision Reference 15/2025 provides an overview of the domestic abuse model change.
- 1.5 The service commissioned by Lancashire County Council is interdependent with the service commissioned by the Police and Crime Commissioner with the initial risk assessment and safety planning service referring victims onto the Lancashire County Council commission for longer term support.
- 1.6 As per the Independent Needs Assessment, conducted by Tonic in 2024, this recommendation seeks to work closer with domestic abuse commissioned services across Lancashire and reduce duplication, resulting in a seamless service for victims of domestic abuse.
- 1.6 As per Appendix D of recommendation 15/2025, the OPCC intends to allocate £430,820.00 to the DASSL partnership (uplift to Lancashire County Council commission).
- 1.7 The uplift into the Lancashire County Council contract will be formalised utilising a Memorandum of Understanding (MOU). The MOU will cover two years funding.
- 1.8 The Office of the Police and Crime Commissioner will work with Lancashire County Council to develop a service specification for the Lancashire County Council contract variation. The Office of the Police and Crime Commissioner will monitor the uplift through quarterly performance meetings alongside County Council partners.

2. Links to the Police and Crime Plan

The Police and Crime Commissioner has a statutory duty to fund support services for victims of crime.

This decision supports the commitment to Prevent Violence Against Women and Girls, Priority 1 in the Police and Crime Plan.

3. Consultations

The addendum to the 2024 Needs Assessment conducted by Tonic consulted local domestic abuse providers and statutory partners. The service specification has been informed utilising the findings of this report.

4. Implications:

a. Legal

Lancashire County Council have sought internal approvals to activate a contract extension, starting April 2026.

Contract variation will cover two years.

b. Financial

The budget allocation for this uplift funding is £430,820.00 per annum. The funding will be allocated through the Ministry of Justice DA/SV allocation.

A Memorandum of Understanding will be established between the OPCC and Lancashire County Council.

Lancashire County Council will vary the contract between themselves and the DASSL partners.

c. Equality Impact Assessment

EIA was completed by LCC – this is under review and will be extended accordingly.
