<b>Executive Summary</b>  This report supersedes previous recommendation for the Umeed Project. It details the joint project between the specialist Domestic Abuse service provider PDVS and BAME support service Preston Muslim Forum.	
<b>Recommendation</b>  The Police and Crime Commissioner is recommended to issue grants of £21,524.02 to Preston Domestic Violence Service and £7,800 to Preston Muslim Forum for delivery of the joint project 'Umeed'.	

## PART I

### 1. Background and Advice

1.1 The Domestic Violence, Crime and Victims Act 2024 introduced the requirement for Community Safety Partnerships to conduct a review following an incident of fatal domestic abuse. The purpose of these reviews is to understand the circumstances leading to a domestic violence-related death, identify lessons learned, and improve responses to domestic violence.

1.2 The Umeed Project brings together a specialist domestic abuse service Preston Domestic Violence Service and a specialist South Asian women's organisation Sahara to co-develop a culturally responsive, trauma-informed support model for women at the intersection of marginalisation and domestic abuse. The project recognises the unique barriers faced by women from minoritised communities—including language, immigration status, cultural stigma, and systemic discrimination—and aims to improve access to safeguarding, support, and justice.

### 1.3 Key Activities:

- Collaborative Development: Joint sessions to share expertise, and co-design improved referral pathways.
- Mentoring Programme: Between staff across both services to build capacity, share best practices, and foster sustainable partnerships.
- Safeguarding Pathway Enhancement: Development of integrated safeguarding protocols that reflect the lived experiences of South Asian women and other marginalised groups.
- Data Collection and Evaluation: Implementation of shared data tools to monitor outcomes, identify trends, and inform future service improvements. This includes anonymised case tracking and feedback mechanisms.
- Community Engagement: Outreach activities to raise awareness and build trust within South Asian communities, ensuring the voices of survivors shape service delivery.
