Executive Summary In 2024 the OPCC conducted an independent assessment of need for victims of crime, one area that was identified as requiring additional investment was therapeutic support for victims of domestic abuse and sexual violence. In December 2025 the Ministry of Justice confirmed an additional 2 year victims grant to the OPCC, and utilising this funding the OPCC went about developing grant guidance for a competitive grants procedure to distribute funding to therapeutic services. The OPCC opened applications for the Sexual Violence and Domestic Abuse Counselling Grant on 2 February 2026 to increase capacity in services delivering specialist therapeutic services to victim survivors of sexual violence and / or domestic abuse. The opportunity was published on the OPCC website and shared via local DA & SV partnership networks. The Police and Crime Commissioner received 6 applications in February 2026, of which all met published eligibility criteria.	
Recommendation The Police and Crime Commissioner is asked to approve the grant allocation of £686,250.82 over 2 years to 3 successful projects; The Birchall Trust, Chorley Women's Centre and HARV Domestic Abuse Services.	

PART I

1. Background and Advice

In December 2025 the Ministry of Justice announced a 2-year funding commitment to PCC's including continuation of the additional grant funding to support victims of Domestic Abuse and Sexual Violence specifically. The MOJ also confirmed the continuation of the arrangements for RASASF paid direct to providers under previous arrangements.

In 2024 the OPCC supported an independent assessment of victims needs, and whilst the PCC had been funding counselling provision to victims of DA/SV for a number of years this identified further investment was recommended to meet increasing demand. As such the PCC made the decision to run a competitive grants round with ringfenced funding to DA and SV Counselling and Therapeutic Services for 2 year delivery of services.

Following the above objectives, the OPCC opened the fund on 2 February 2026 to support increased capacity in specialist counselling services for victims and survivors of sexual violence and domestic abuse.

Key objectives included:

- Complement not duplicate the delivery of the services under the RASASF (currently delivered by Birchall Trust in Lancashire)
- Increase availability of specialist, trauma-informed counselling for victims and survivors.
- Reduce waiting times for therapeutic support, particularly for those experiencing significant risk or complex trauma.
- Improve accessibility for underrepresented or marginalised groups.
- Support sustainable delivery models that complement statutory and voluntary sector provision.
- Accept referrals self-referrals as well as consent-based referrals from organisations commissioned by the OPCC including the domestic abuse IDVA and sexual violence ISVA Service providers and the Sexual Assault Referral Centre (SARC).
- Counselling should be free at the point of access.

The applications were assessed internally using both the Grant Guidance (Appendix B) and the Scoring Matrix (Appendix C).

Following the assessment process, the applications received the following scores:

Those applications which scored 4 and above have been selected for recommendation to support.

The Birchall Trust £539,657, Chorley Women's Centre £65,000 and HARV Domestic Abuse Services £81,593.82 over a 2-year period.
